#### BEACHSIDE TENNIS VILLAS CHECKLIST FOR APPLICATION FOR INTERIOR RENOVATIONS May 15, 2024

All modifications and/or interior alterations to a villa or its deck/balcony require prior approval from the board. Any changes to the villa exterior including doors, windows, new wall penetrations, or common areas are prohibited. This requirement does not apply to routine maintenance or repairs such as painting, carpeting, appliance repair/replacement, and the like. All communications regarding renovations should be directed to IMC.

# Scope of Work

- All work must comply with the provisions set forth in the Master Deed, Bylaws, and Rules of Beachside Tennis Villas, the Covenants and Rules of Sea Pines, and local building codes.
- All work is limited to the confines of the unit involved and cannot extend to common property or limited common property.
- All work must be undertaken in a manner that is safe, does not compromise the integrity of the building, or adversely affect the enjoyment of other owners and guests.

# Approvals, Permits, and Certifications

Proposals for renovations must be completed to include the following. Blank forms and samples of completed forms are available from IMC.

- Application for Unit Renovations Permit (Exhibit 1)
- Unit Renovations Permit Agreement (Exhibit 2)
- Unit Renovations Permit (Exhibit 3)
- Project Change Request Form (Exhibit 4)
- A detailed waste disposal plan
- Town of Hilton Head building permit
- Certificate of Insurance
- Copy of Contractor's License
- Estimated start and completion dates
- Acknowledgement by unit owner and contractor of compliance with the Rules and Regulations for Renovations of Individual Units of BTV

## Work Hours and Noise Restrictions

- Work hours are limited to 8:00 AM to 5:00 PM, Monday through Saturday
  - No work may be conducted on the following days without board approval
    - From the Friday before Memorial Day through Labor Day
    - From Christmas Eve through New Year's Day
    - From Monday through Sunday of the Heritage Golf Week
    - On South Carolina Holidays
- Any work generating excessive noise for prolonged periods requires advanced scheduling and must be approved by the board. A minimum of three (3) business days' notice is required.
- When used to transport materials, equipment or debris, the elevator walls, floor, and ceiling should be protected from damage.


